DOT resident maintenance engineer, Donald Schumann, presented plans for a detour through Conrad from approximately June 9, 1980 through October 3, 1980. A .6 mile section of Highway 14 will be reconstructed during this time. The detour would be from Highway 14 east on County Road D-67 to Conrad, east on Conrad's Center Street, then north on Main Street to the Grundy County road, north to County Road D-55 and west to Highway 14. The council was concerned with the safty of children in the pool area and the intersection of Lillian and Main, during school time, and also with congestion during Conrad's Centennial celebration, July 4,5,&6. On these three days traffic can be rerouted north on Washington Street instead of North on Main Street. The council discussed stop signs for the pool area and the intersection of Main and Lillian streets.

The League of Iowa Municipalities insurance representative, Howard Hogan, presented their group insurance coverage in regard to life, major medical, dental and income replacement. He stated the open enrollment period began March 1st and ran through April 30th.

Larry Neal, a resident of Conrad's Cedar Crest addition, reported that the residents of that addition are checking with Iowa Electric Light and Power in regard to laying natural gas lines there. It was agreed by the council that the lines should be laid in the easment.

Dave Fox, from Clapsaddle-Garber Associates, stated that our existing sewage plant does not meet the EPA treatment standard in regard to reliability, the trickling filter and the plants distance from residences in the area. After discusson, the council agreed to improve our present system and lines as the need arises and wait until necessary to proceed with a new plant.

The Council also asked Fox, that Clapsaddle-Garber inform BARCO to obtain and install valves that are in question for the new fire station.
