plans, specifications and form of contract were filed with
the Town Clerk of Conrad, Iowa, for the construction of
asphaltic paving with rolled stone base, concrete curb
and gutter, necessary storm sewers and concrete sidewalks
within the Town of Conrad, Iowa; and
