ORDINANCE No, 60,

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF CONRAD&IOWA.

SECTION 1. it shall be unlawful to maintain or operate gasoline
 clothes cleaning machines within the fire limits,
 unless such machine is in a separate detached building at least
 fifty feet from any other building.

SECTION 2. Anyone violating any of the provisions of this ordinance,
 shall upon conviction, be subject to imprisonment not exceeding
 thirty days, or to a fine not exceeding one Hundred Dollars.
 Whenever the fine and costs imposed for the violation of this
 Ordinance are not paid, the person convicted may be committed
 to jail untill the fine and costs are paid, not to exceed thirty days.

SECTION 3. this ordinance shall be in force and effect from and
 after its passage and publication as provided by law.
