Moved by Newton and seconded by Dostal that we hire R A Prescott as our night watch, at \$35.00 per Mo, Carried.

Moved by Wheeler and seconded by Creuse that the said resolution be adopted, the Mayer declared it adopted.

Moved by Dostal and seconded by Wheeler that Gravenstine act as our weed commishner, Carried.

Moved by Newton and seconded by Dostal that we buy Flanders star, for 00¢

Moved by Wheeler and seconded by Creuse that we have the hall redeccerated and have Mrs Carnes to clean it all up, Carried.

Moved by Wheeler and seconded by Creuse that the Clerk be instructed to take care of Pipers Beer permit, Carried.

Moved by Newton and second by Dostal as an agreement between the Mayer and Council the shares on Fire Truck be \$25.00 Carried.

Moved and seconded that we adjourn, Carried.
