

MINUTES OF SPECIAL MEETING OF THE

DAY OF September, 1950.

A special meeting of the Town Council of the Town of Conrad, Iowa, was held in the Council Chamber on the 7th day of September, 1950, pursuant to notice given to each member of the Town Council, which notice is on file with the Town Clerk and is a part of the records of said Town.
